### **CHAIRMAN'S REPORT**

Members,

At the Annual General Meeting held on Sunday 22nd September the following members were elected to the Board:

Chairman - Graham Chattin
Business Manager - Reg Walls
Treasurer - Jim Brown
Secretary - Trish Hassam
House Director - Jeff McLennan
Greens Director - Geoff Devencorn

Ken Peters, Greens Director, and Grant Upton, Bowls Director, retired from the Board. I offer my sincere thanks to these gentlemen who were both very effective in their roles, particularly Ken Peters, who battled serious health problems throughout the year. Grant has agreed to continue to assist in the supervision of the barefoot bowls and to assist the new Bowls Director — when we are able to appoint someone.

The position of Bowls Director is not a difficult job but a very important one because the development of barefoot bowls will provide a very strong revenue stream for the club. The role requires someone who has good organisational and personal skills to be able to coordinate and run the barefoot bowls in cooperation with our Club Manager and with the assistance of a reliable and enthusiastic team of volunteers who are rostered to look after each group. I would like to see one of our ladies take on this role because we desperately need another female on the Board. We need more representation from the ladies to ensure the best interests of the ladies are preserved in the decision making processes.

Congratulations to Roger Piaseki who has again taken on the role of Men's Section President and to Bev Geldart who was re-elected as President of the Ladies Section. The Section Presidents attend the Board meetings and it is essential they be included to ensure the lines of communication are always open to facilitate the smooth operation of the Club.

Congratulations also to those members elected to Committee positions for the first time and those members who were re-elected.

The club does not function without these members taking on this responsibility and I look forward to a very productive and profitable new year.

The proposal for the purchase and installation of a solar power system was approved by the members at the AGM. It was suggested that a way to fund the project would be for the Club to issue Debentures to allow the members to invest in the future of their club and I was very pleasantly surprised to see the positive and enthusiastic response from the members.

The issuing of Debentures will provide the members with an opportunity to earn far better interest than currently available from the banks and most superannuation funds while at the same time providing the Club with access to sufficient funds, at a reasonable interest rate, to undertake essential development projects such as the solar power proposal.

The Board will now seek legal advice and prepare a prospectus for distribution to the members for their consideration. Legal documentation will also be prepared, in line with ASIC regulations, to protect the interests of the members and the Club.

Thanks to Les Ockendon, we have found a folder that includes all the documentation for a Debenture issue that dates back to October 1969 when the Club wanted to raise \$30,000 to redevelop the Club premises. The cost of the project at that time was \$51,786. When you consider you could purchase a new home at Rochedale in 1970 for around \$12,000 it was a lot of money. In 1969 I was earning around \$66 per week as a tradesman and my wife and I paid \$320 for a week on Lindeman Island for our honeymoon in November 1969. What a difference 50 years makes.

Keep bowling a good line and length everyone.

## COACHING - RON WALTON

#### 29 IRREGULARITIES DURING PLAY

- **29.1** Playing out of turn
- **29.1.1** If a player plays out of turn, the opposing skip can stop the bowl & return it to the player to play it in the proper order.
- **29.1.2** If a bowl has come to rest & has not disturbed the head, the opposing skip must choose whether to:
- **29.1.2.1** Leave the head as it is & have their team play two bowls one after the other to get back to the proper order of play; or
- 29.1.2.2 Return the bowl & get back to the proper order of play.
- **29.1.3** If the bowl has disturbed the head, the opposing skip must choose whether to:
- 29.1.3.1 Leave the disturbed head as it is & have their team play two bowls one after the other to get back to proper order of play;
- 29.1.3.2 Replace the head in its former position, return the bowl & go back to the proper order of play; or
- **29.1.3.3** Declare the end dead.

### Scomo's Tax Offset for low and middle income earners

If you are an Australian resident for income tax purposes and you pay tax on your taxable income, you may be eligible low income tax offset OR
 low and middle income tax offset.

You don't have to do anything to claim the offsets. ATO will work them out for you when you lodge your tax return.

Tax offsets reduce the amount of tax payable on taxable income. These are non-refundable offsets, so the following applies:

- · any eligible offset amount can only reduce your tax payable to zero, any unused offset amount can't be refunded
- it can't reduce your Medicare levy.

If your taxable income is less than \$66,667, you will get the low income tax offset.

Low and middle income tax offset - If your taxable income is less than \$126,000, you will get some of the low and middle income tax offset. The maximum offset is \$1080 per annum. The base amount is \$255 per annum.

The new low and middle income tax offset is available for the 2018-19, 2019-20, 2020-21 and 2021-22 income years and is in addition to the low income tax offset. If your taxable income:

- does not exceed \$37,000, you will be entitled to an offset amount of \$255 on your tax payable.
- exceeds \$37,000 but is not more than \$48,000, you will be entitled to an offset amount of \$255, plus 7.5% of the excess above \$37,000 to a maximum offset of \$1,080 on your tax payable.
- exceeds \$48,000 but is not more than \$90,000, you will be entitled to the maximum offset amount of \$1,080 on your tax payable.
- exceeds \$90,000 but is not more than \$126,000, you will be entitled to an offset amount \$1,080 less 3% of your taxable income above \$90,000.

### Changes to Deeming Rates

The deeming rates used to assess your income are being lowered from July 1st.

Centrelink use an income and asset test to work how much they can pay you. They include any deemed income in the income test. Deeming assumes that your financial investments earn a set rate of income, no matter what they really earn.

How Centrelink work out your deemed income depends on your circumstances. Centrelink apply a lower deemed rate to a certain amount of your total financial investments. Anything over that amount is deemed at a higher rate.

The lower deemed rate is 1.75%. This will drop to 1%.

The higher deemed rate is 3.25%. This will drop to 3%.

Centrelink will backdate the change to 1 July 2019, and apply the new rates from this date. You don't need to do anything. If you have deemed income, Centrelink will automatically apply the new deeming rates. You may see a change in your regular payment rate after the new deeming rates have been updated.

For Singles - the first \$51,800 of your financial assets has the deemed rate of 1% applied. Anything over \$51,800 is deemed to earn 3%.

If you're a member of a couple and at least one of you get a pension, the first \$86,200 of your combined financial assets has the deemed rate of 1% applied. Anything over \$86,200 is deemed to earn 3%.

If you're a member of a couple and neither of you get a pension, the first \$43,100 of each of your own and your share of joint financial assets has a deemed income of 1% per year. Anything over \$43,100 is deemed to earn 3%.
